BY-LAW #2020-003 OF THE VILLAGE OF ROCKYFORD IN THE PROVINCE OF ALBERTA

BEING A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE VILLAGE OF ROCKYFORD FOR THE 2019 TAXATION YEAR.

WHEREAS, the Village of Rockyford has prepared and adopted detailed estimates of the municipal revenue and expenditures as required, at the council meeting held on April 8, 2020 and

WHEREAS the estimated municipal expenditures and transfers set out in the budget for the Village of Rockyford for 2020 total \$ 865,221.97;

and

WHEREAS, the estimated municipal revenues and transfers from all sources other than property taxation is estimated \$ 505,934.20; and the balance of \$ 359,287.77 is to be raised by general municipal taxation; and \$ 83,829.46 for education taxation 2020 Education Property Tax Requisition; \$2,160 for the Wheatland Foundation and Housing Management Body and \$35.25 for Designated Industrial Property Requisition:

WHEREAS, the Council is authorized to classify assessed property, and to establish different rates of taxation in respect to each class of property, subject to the Municipal Government Act, Chapter M26.1, Revised Statutes of Alberta, 2000;
