Miss Rodeo Rockyford Applicant Provisions

Application Closing Date: Completed applications must be received on or before **June 5, 2025**.

Eligibility:

In order to be eligible to participate in the competition, the applicant must:

1. Be a female who between the ages of 18-25 years of age as of September 1, 2025
2. Never have been married or lived common-law, been pregnant, had a child or pleaded guilty to or found guilty of a criminal offense;
3. Be a Canadian Citizen;
4. a) Contestants must be a person who has her principal place of residence within a reasonable radius of the Rockyford area.
b) The decision of who has, and who has not, her principal place of residence in this area rests solely on the Miss Rodeo Rockyford committee.
5. All applicants must have an Alberta Equestrian Federation Membership

Point For Resume: A point form resume no longer than two pages is required. The document is to be typed, double-spaced and organized in the chronologically, functionally or a combined thereof, and in the applicant's personal style. Handwritten resumes will not be accepted. Resumes must be on plain white paper.

Driver's Abstract: The original of the contestant's current, valid driver's abstract are required with the entry application package. Miss Rodeo Rockyford is responsible for insurance covering a clean driver's abstract. Additional costs of alternative or additional insurance will be the responsibility of the applicant.

Photographs: Photographs are required for marketing materials including media promotions and programs.

Please send:

- One color headshot in digital form in high-resolution format.
- One printed 5" x 7" photo of your choice is also required.

Contestant photographs must be Head & Shoulder photo in full western attire with a cowboy hat. Photographer's release must accompany the photographs, or they cannot be used.

Miss Rodeo Rockyford Rules & Regulations

1. Miss Rodeo Rockyford Contestants must be between the ages of 18-25 years of age as of September 1, 2025

2. Entries must be received on or before **June 5th, 2025**.

4. Miss Rodeo Rockyford contestants must not have pleaded guilty to or have been found guilty of an offense pursuant to the Criminal Code of Canada

5. Miss Rodeo Rockyford contestants must be a female, never married or have lived common law and have never been pregnant. If the queen becomes pregnant, married, or living common during her reign, she will forfeit her crown and all benefits derived from the pageant and winning the title.

7. If a contestant and/or the Queen resigns/quits/forfeits from the competition and/or her title she will be required to return **every** item and benefit that she received during the pageant and/or from winning Queen within 2 weeks of resigning/quitting to a location determined by the Miss Rodeo Rockyford Committee at the Queen's own cost.

8. Contestants must own a horse, or have a horse available for her during the queen competition and for her reign as Queen. Suitability of the horse will be up to the Miss Rodeo Rockyford Committee and that suitability can be decided on at anytime during the competitions or her reign as Queen. If for some reason your horse is not suitable it will be a requirement of contestant/Queen to find a new suitable horse, the Miss Rodeo Rockyford Committee and the Rockyford Ag Society is not required to find you a horse.

9. Contestants will not use foul language, consume any alcohol, smoke or partake in any illegal drugs during this contest and or her reign. It is important that you remember you are a representative of the Rockyford Ag Society and you must maintain decorum at all of your events in public and on all Social Media Platforms.

10. Contestants must attend each and every scheduled function during the months of competition and be willing to fulfill the commitments during her reign, which can include weekend and weekday appearances. It will be expected that they will dress and act in accordance with the positions that they hold.

11. Contestants must be prompt and on time throughout this contest. Tardiness will **not** be tolerated. Contestant can never leave an event without first receiving permission from the event chaperone or the Miss Rodeo Rockyford Coordinator. Same expectations will be held during your full year if you receive the Queen title.



12. Contestants are not authorized to attend any function or event without the approval from the Miss Rodeo Rockyford Committee. Contestants are not authorized to attend any function or event without a chaperone that has been approved by the Miss Rodeo Rockyford Committee.

13. Contestants cannot enter another rodeo queen competition while she is running for the title of Miss Rodeo Rockyford. Contestants may enter the Miss Rodeo Rockyford Contest a maximum of three times.

14. Contestants may run into uncomfortable situations or rude people, contestants must keep their composure and if assistance is needed, notify the chaperone.

15. There will be media at most events that you attend. When dealing with the media, be positive in both actions and in words. Negative or controversial actions reflect poorly on both you and the organization that you represent. Think before you speak and be positive.

16. Respect must be shown to all committee members, directors, staff, executive of the Rockyford Ag Society & Rodeo Committee members and the hosts of the various functions attended at all times. Contestants are to treat fellow contestants with utmost respect. All Contestants can expect to be treated with respect by the Rodeo Committee and Queen Committee Representatives.

17. Contestants must represent their rodeo and community to the best of their ability. **Even when you remove your hat and banner you must present yourself respectfully.**

18. The newly crowned Miss Rodeo Rockyford will enter into an agreement with the Miss Rodeo Rockyford Committee and Rockyford Ag Society immediately after being crowned.

19. The Contestant acknowledges by her signature hereto, that the terms and conditions contained herein have been reviewed with her, and she has had an opportunity to consider such terms and conditions and has also had an opportunity to receive independent legal advice (and has either received such independent legal advice or has waived her right to do so) with respect to such terms and conditions and all such restrictions contained in this Agreement are reasonable and valid and all defenses to the strict enforcement thereof by Miss Rodeo Rockyford are hereby waived by the Contestant.

20. The Contestant acknowledges that she must complete her crowned year as Miss Rodeo Rockyford before she is able to run for the title of Miss Rodeo Canada. The Miss Rodeo Rockyford committee and the Rockyford Ag Society have the final decision as to each contestant's ability to participate in the Miss Rodeo Canada pageant.

Criminal Offence Definitions

Definitions: For the purpose of the Eligibility Rules, the following definitions of a criminal offence apply:

“guilty” in relation to a plea or a finding, includes an absolute or conditional discharge;

“offence” means:

- a) A summary of conviction or indictable offence under the Criminal Code
 - a. (Canada);
- b) A misdemeanor or felony under the criminal legislation of the United States of America or of any state or territory of the United States of America;
- c) An offence under the criminal legislation of any other jurisdiction;
- d) A quasi-criminal offence, for example under the Income Tax Act (Canada) or the tax legislation of any jurisdiction; or the securities legislation of any jurisdiction;

And excludes

- e) An offence for which a pardon has been granted and has not been revoked under the Criminal Record Act (Canada) or the comparable legislation or any other jurisdiction, and;
- f) An offence which is an offence only under the motor vehicles legislation of any jurisdiction.

NOTE: With the exception of offences under the Young Offender Act (RS 1985 ch. Y-1) or its predecessor, the granting of a Pardon with respect to an offence is not automatic, but must be formally applied for and granted to the offender pursuant to the Criminal Records Act (Canada). Therefore, it is not considered appropriate to omit reference to an offence under any statute other than the Young Offenders Act (Canada) or its predecessor on the basis of an assumption that a Pardon of the offence is automatic after a given period of time.
